**Per Child Allotment Program Report Code (PRC) 063 Funds**

The per child allotment rate for the Community Residential Center (CRC) Program will remain the same for the 2016-2017 school year. The community residential rate for children with disabilities ages 3 through 21 is \$14,940.00 for 10 months of service including \$50.00 per children for instructional supplies.

Three-month base allotments are calculated using the number of students placed in a CRC at the close of the 2015-2016 school year, multiplied by \$4,482.00 (3 months of funding) Financial and Business Services will soon release base allotments to LEAs.

Funding requests for additional children are based on the availability of funds. A CRC application, which is due on **September 15, 2016**, must be submitted in order to receive the remaining seven (7) months of funding. The application is available at:
