Per Child Allotment Program Report Code (PRC) 063 Funds

The per child grant fund allotment for the Developmental Day Center (DDC) Program will remain the same for the 2016-2017 school year. The developmental day funding amount for children with disabilities age 3 through 21 is \$10,041.00 for 10 months of service, including \$50.00 per child for instructional supplies.

Attached is a list of the developmental day base allotments for each local education agency (LEA) for the 2016-2017 school year. Three-month base allotments are calculated using the number of students placed in a DDC at the close of the 2015-2016 school year, multiplied by \$3,012.30 (3-months of funding at \$1,004 each month). Financial and Business Services will soon release base allotments to LEAs.

Funding requests are based on the availability of funds. Additional funds will be disbursed after a DDC application has been received by the September 15, 2016 due date and approved. The second allotment will be the total approved amount minus this 3-month base allotment.
