North Carolina offers a number of feedback opportunities and modalities related to assess need and inform the distribution of funding across the state. Most notable, the state State Systemic Improvement Plan (SSIP) includes a comprehensive needs assessment at the local level (the LEA Self-Assessment) that is aggregated at the regional and state level to elucidate priorities and identify activities that can be scaled across the state. In addition, feedback opportunities occur regularly through the year, which include webinars, quarterly Regional Director/Coordinator meetings, monthly meetings of the Director's Advisory Council, the Exceptional Children Statewide Stakeholder Collaborative, content focused stakeholder groups, and the Council on Educational Services for Exceptional Children. Finally, the website is leveraged for public comment to gain LEA input.

¹Each State may reserve for each fiscal year not more than the maximum amount the State was eligible to reserve for State administration under this section for fiscal year 2004 or \$800,000 (adjusted in accordance with 20 U.S.C. 1411(e)(1)(B)), whichever is greater; and each outlying area may reserve for each fiscal year not more than 5 percent of the amount the outlying area receives under 20 U.S.C. 1411(b)(1) for the fiscal year or \$35,000, whichever is greater.

- If the homebound instruction is determined to be the least restrictive alternative environment, the IEP Team is required to meet to determine the nature of the homebound educational services to be provided to the student.
- The designee or designees of the student's IEP Team conducts a monthly evaluation of the continued appropriateness of the homebound instruction.

These difficulties typically result from a deficit in the phonological component of language that is often unexpected in relation to other cognitive abilities and the provision of effective classroom instruction. Secondary consequences may include problems in reading comprehension and reduced reading experience that can impede growth of vocabulary and background knowledge.

NC 1503-3.3 SLD Technical Correction

North Carolina made a technical correction concerning the public agency's responsibility to obtain consent and evaluate a child suspected of a Specific Learning Disability. The technical correction was consistent with the corresponding federal regulation (34 CFR 300.309).
