**Training Announcement:** NC Foundations - Preschool Pyramid Emotional-Social Development Tier I Trainer Modules (formerly Social Emotional Foundations of Early Learning)

NCDPI's Office of Early Learning would like to announce a train-the-trainer opportunity for early childhood professional development providers in support of the tiered model of promoting social-emotional development in young children. Eleven modules will be presented, which contain content for Tier I core instructional practices and are aligned with the NC Foundations for Early Learning and Development standards and the NC Professional Teaching Standards. While these modules are available online (<http://modules.nceIn.fpg.unc.edu/self-paced-modules>), the number of requests for face-to-face trainer sessions prompted the Department to organize three summer sessions conducted by the Early Learning Network (<http://nceIn.fpg.unc.edu/>).
